## **Author guidelines**

*Investigación Económica* is a peer reviewed scientific journal. All manuscripts must be original and unpublished, and should not be submitted simultaneously for publication elsewhere (see our "Editorial Ethics", its statements must be signed by all the authors of the paper).

*Investigación Económica* publishes articles with the highest scientific standards, with contents relevant and timely, for theoretical discussions and for the analysis of economic policies. We accept papers in English or Spanish.

Investigación Económica welcomes contributions that replicate previously published research in this and other journals. In deciding whether to publish a replication study, we do not discriminate on the basis of the outcome of the study. That is, it makes no difference whether the replication study confirms or disconfirms the original study. What matters is the thoroughness and quality of the analysis. In the same direction, Investigación Económica welcomes contributions that report cases of "failures" instead of "success".

All works will be reviewed by members of the Editorial Team and by two anonymous pairs. Under no circumstances our decision can be appealed. Once a decision has been made, final approval is subject to changes in style, form and content that the editor may have communicated with the author. Authors are responsible for the content of their work and for the correct use of the references they have cited. The journal reserves the right to make changes in accordance to our editorial policy.

Investigación Económica will certify empirical articles doubly, that is, we will review the quality of the databases, and we will replicate their quantitative exercises, partially or fully. We will make a similar effort in the case of articles that use simulation methods. In this regard I want to advance that our Technical Team, together with some editorial board members, will elaborate evaluations that I will post at the end of the empirical articles. For now, I invite authors to request this certification voluntarily and to share with Investigación Económica their databases and codes used to perform statistical and mathematical exercises. In a second phase, this invitation will be obligatory (see our "Editor's Note" for more information).

Publishing is subject to the editorial guidelines described below. Failure to meet any of the requirements will result in the work not being reviewed. We cannot return original submissions. All papers must be sent to the address of the journal <invecon@unam.mx>, with copy to <cguerrero@economia.unam.mx>. Once received, Investigación Económica will acknowledge receipt to the sender.

- 1. The written text will adhere to the following requirements:
  - a) A Cover page that includes the following: Title of the paper, Full name of the author(s), Brief academic and professional resume, Office address and phone number, and Email address.
  - b) A summary of your paper between 10 lines long.
  - c) Include the classification numbers (JEL), and key words.

- 2. Any proposed text should be submitted according to the following guidelines:
  - a) Including all sections of the manuscript, articles cannot exceed 35 pages in length.
  - b) Will be processed in MS Word.
  - c) The font will be Garamond, size 12.
  - d) Paper is letter sized. Pages must be double spaced.
  - e) Do not use indentation. Neither in the text nor in the cited references.
  - *f*) The use of italics is reserved for the title of books, journals, scientific names and non-Spanish words.
  - *g*) Quotation marks are reserved for the title of journal articles, chapters in books or quotes included in the text.
  - h) Emphasize what you want to highlight.
- 3. Tables, graphs and other supporting materials will follow these requirements:
  - *a*) Preferably processed in Excel format, or sent in any of the following formats: jpeg, tiff, png, or gif.
  - b) Must be given originals in a single file.
  - c) Include materials into the text.
  - *d)* Must be self explanatory (without the need to refer to text). Do not include abbreviations. Clearly indicate units of measurement and include full citations.
  - e) Graphs and other supporting material must be in black and white.
  - *f*) Tables must be simple and relevant.
  - *g*) Titles, notes and sources of material should be captured as part of the text of the document, not in the body of the graph, figure or table.
- 4. Use footnotes sparingly and only to provide essential information.
- 5. Quotations and references in the text must meet the criteria established by the Harvard System of Referencing. For example: (Varian, 1992, p. 21). To indicate the number of page: preceded by p. for a single page and pp. for a series of pages.
- 6. Explain at least once any abbreviations you use in your work.
- 7. The final bibliography must also meet the criteria established by the Harvard System of Referencing. The list of references must correspond with citations within the document.
